2. Assumption of Risk

I understand that participation in Edmonton Raptors involves physical activities, outdoor adventures, and other recreational events that may carry inherent risks, including but not limited to:

- Physical injury (e.g., cuts, bruises, sprains, or fractures).
- Exposure to outdoor elements (e.g., sun, insects, or weather conditions).
- Accidents during activities such as swimming, hiking, sports, or crafts.

I acknowledge that while the camp staff will take reasonable precautions to ensure the safety of all participants, it is impossible to eliminate all risks associated with these activities.

3. Release of Liability

In consideration of my child's participation in Edmonton Raptors, I hereby release, waive, discharge, and hold harmless. Its directors, employees, volunteers, agents, and

representatives from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, or injury that may be sustained by my child or myself while participating in the camp.

This release of liability includes, but is not limited to, injuries or damages caused by negligence, acts of other participants, or unforeseen circumstances beyond the control of the camp organizers.

4. Medical Authorization

In the event of an emergency, I authorize the camp staff to seek and provide medical treatment for my child as deemed necessary. I understand that every effort will be made to contact me or the emergency contact listed above before taking such action.

I certify that my child is in good health and has no physical, emotional, or mental conditions that would prevent their safe participation in camp activities. I agree to inform the camp staff of any allergies, medical conditions, or special needs my child may have.

5. Code of Conduct

I understand that my child is expected to follow the camp's rules and code of conduct. If my child's behavior poses a risk to themselves or others, or disrupts the camp environment, I acknowledge that the camp reserves the right to dismiss my child from the program without a refund.

6. Photo/Video Release

I grant Edmonton Raptors permission to use photographs, videos, or other media of my child taken during camp activities for promotional purposes, including but not limited to social media, websites, and printed materials. If I do not wish to grant this permission, I will notify the camp in writing prior to the start of the program.

7. Acknowledgment of Understanding

I have read this waiver and release of liability form in its entirety. I fully understand its terms and acknowledge that I am giving up certain legal rights, including the right to sue. I sign this document voluntarily and agree to be bound by its terms.
